Version 2.5

Summary

Version 2.5 of the Lease Accounting System for Windows contains enhancements to a number of processes. Most of these enhancements have been requested by one or more of our current customers to increase the functionality of our current version.

Data files will need to be converted prior to user access. A.L.S. will perform the conversion process. The conversion can be done remotely or in conjunction with a training session to familiarize the users with the new features and changes.

The following release information covers the majority of software enhancements and revisions. Other minor changes may be included in the update.

Added Features and Highlights

The following highlights the most significant changes from our A.L.S. Lease Accounting and Management for Windows version 2.0 to version 2.5. Following the highlights section is a detailed description of all of the changes by category.

*****New Module Available (9/11)***** We have a new module available that creates the NACHA file to pull one time and recurring payments for ACH customers and one time payments for accounts setup for deficiency billing. Includes a feature to refund, cancel or delete scheduled ACH payments. Please contact a customer support rep. if you are interested in purchasing this module.

*****New Module Available (2/10)***** We have a new module available that gives you the ability to e-mail invoices and late notices to your customers. Please contact a customer support rep. if you are interested in purchasing this module.

These new products allow you to scan images and file them in a document directory easily accessed through your lease system. System Wide Enhancements

Added a message if a parsed name is incomplete. Message will appear if either the first or last name field is left blank. (5/06)

Customer's names now print in first, middle, last name order on invoices, labels, late notices, insurance letters and odometer disclosure statements. (2/10)

Added a "next" button on account lookup screens to increase the speed of lookups. (2/10)

Added a Copy/Paste button to all remarks screens (Collections, Title, Insurance and General Remarks) which allows you to highlight and copy lessee and guarantor information from the screen. Also includes driver information if different than lessee. (2/12)

Added options for memo writer to print memo or letter addressed to the customer. (2/08)

G/L Interface Files have been moved to a special directory and are kept for one year. The file names were also changed so they will not get overwritten when more than one cycle is run on the same day. (4/12)

Lease Processing

All Programs

Re-leases – We have added the ability to assign any lease number you wish for your re-leased asset. The re-lease will still contain a re-lease digit to indicate the number of times the asset has been released and will also retain the necessary information for your corporate tax report. This change was made to accommodate our users that have a need to change the lease number with each re-lease. The ability to keep the same lease number with the re-lease digit is still in place. (2/08)

Payoff Types – Added a new standard payoff type. Payoff type #8 – Remaining Payments + Residual + Termination Charges. (10/14)

Lease Data Entry

New Lease Input

Added ability to enter a check number even if you choose A/P for disbursement to dealer. (2/10)

Added weekly and bi-weekly payment options for ALS Complete systems by request only. ALS Lite systems must purchase the complex payments module. (9/06)

Number of up-front payments no longer limited. (8/06)

Miscellaneous

Demographic Data

Added lessee social security number under lessee information and driver information. If social security number for driver is the same as lessee it will automatically fill in when you enter through the field. (10/05)

VIN – all lowercase letters automatically change to uppercase when entered. (5/09)

Increased size in mileage cap to accommodate in excess of 999,999.

Guarantor Information Input

If a lease is marked that there is no guarantor/co-maker, the guarantor/co-maker input screen will not automatically come up during initial lease input. (6/06)

Insurance Information Input

Added lease status to the insurance input screen. (2/10)

Added the ability to exclude specific leases from being updated with the master fleet lease insurance information during the cycle process. (9/06)

Reprint Disbursements

Added the ability to reprint inventory charge off disbursements. (1/13)

Loan Processing

Note: When concurrent loans reduce to zero the payoff date is automatically set to the current cycle date.(7/14)

Lease Terminations

Added the maturity date to the screen. (2/10)

Added the type of "write-off" for terminations. (10/13)

Added the ability to enter the Date of First Delinquency (DOFD) to the termination screens. If you have the credit bureau processing module, a DOFD is required if you are placing the asset in inventory with an inventory code of (4) Repossession or (5) Voluntary Repossession. We also now check for DOFD if the following credit bureau status codes are used 61-65, 71, 78, 80, 82-84, 88, 89, 93-97. (5/10)

Lease Redemption

Process has been modified to perform redemption automatically going forward. Any leases currently in an off-lease status will need to be redeemed manually. (2/08)

Inventory Charge Off

Added a disbursement printout to show general ledger entries made with the charge off. (1/13)

Contract Functions

Consumer Info Indicators W, X and Y are no longer valid. If you have included any of those indicators on your accounts they will be sent as blank to the bureau. (11/10)

If account status is set to DF or DA then report once more and mark to exclude from future reports. (11/11)

Added a simple CSV file that lists account, status code reported, payment rating reported, if account was marked to exclude, and whether a test run was executed to produce this data. (2/13)

Made changes to check for a DOFD (Date of First Delinquency) if a Status Code 96 is used. DOFD is required for this status code but a payment rating does not need to be calculated. (7/13)

Made changes to not clear the DOFD for Status Codes 96 and 95 based on payment rating calculated. (9/13)
